#### Answer Justification :

**Learning:** Schedule I and part II of Schedule II provide absolute protection - offences under these are prescribed the highest penalties.

Species listed in Schedule III and Schedule IV are also protected, but the penalties are much lower.

Schedule V includes the animals which may be hunted. The plants in Schedule VI are prohibited from cultivation and planting.

**Justification:** Even if you do not know about the location of all these national parks, you can guess the answer by the location of Eravikulam national park which is located in Kerala (same state as Anaimudi Shola park).

Parks in options B and C are located mostly in North or NE India. Parks in Option D are located in AP, MH and A&N.

So, the best guess can be A, which is also the answer.

**Learning:** Mathikettan Shola National Park, Eravikulam National Park, Pambadum Shola National Park, Chinnar Wildlife Sanctuary and the Kurinjimala Sanctuary, all of these surround this protected area.

This national park forms part of the Anamalai sub-cluster, which was recently nominated for consideration for World Heritage Site status under UNESCO's World Heritage Programme.

#### Answer Justification :

**Learning:** The Commission consists of a Central Vigilance Commissioner (Chairperson) and not more than two Vigilance Commissioners (members).

The Central Vigilance Commissioner and the Vigilance Commissioners shall be appointed by the President on recommendation of a Committee consisting of the Prime Minister (Chairperson), the Minister of Home Affairs (Member) and the Leader of the Opposition in the House of the People (Member).

The term of office of the Central Vigilance Commissioner and the Vigilance Commissioners would be four years from the date on which they enter their office or till they attain the age of 65 years, whichever is earlier.

The Commission, while conducting the inquiry, shall have all the powers of a Civil Court with respect to certain aspects.

#### Answer Justification :

**Learning:** The Cartagena Declaration on Refugees was adopted by the Colloquium on the International Protection of Refugees in Central America, Mexico and Panama in 1984.

The declaration is a non-binding agreement but has been incorporated in refugee law in various countries. Its principles are based on the 1951 UN Refugee Convention and the 1967 Protocol.

The Declaration reaffirms the importance of the right to asylum, the principle of non-refoulment and the importance of finding durable solutions.
